

Author's update 2016/2017:

1. The Vanderbilt University School of Medicine at Nashville, TN in the US set up a database in 2016 containing around 1,200 scientific references pertaining to parental alienation (<http://www.mc.vanderbilt.edu/pasg/>).
2. In a beta version of ICD-11, parental alienation is currently being discussed as a possible diagnosis labelled as “caregiver-child relational problem” (departing from the current US American DSM-5).
3. The Parental Alienation Study Group now has about 400 members from 43 countries (cf. <https://pasg.info>).
4. Two documentaries on the subject of abduction and alienation were released in 2005 (“Victims of another War”) and 2016 (“Sarah Cecilie”), which describe parental alienation and its long-term consequences.
